The implementation of **Positive Energy Districts (PEDs)** serves as an ambitious and valuable contribution to achieving these crucial targets – the **PED Programme** aims to support the planning, large-scale implementation and replication of 100 PEDs by 2025.

To set up a fitting agenda for Research & Innovation, the PED Programme aims to collaborate closely with cities and urban stakeholders. We therefore invite city representatives, real estate developers, energy providers, building associations, and civil society institutions etc. to the **PED AGORA Workshop on April 3rd in Lisbon** to discuss strategies towards the European-wide implementation of PEDs, to bring in their experiences and perspectives and reflect on current activities, challenges and success stories.



Goals

There is a wide range of **approaches, strategies and solutions regarding the achievement of climate targets and the energy transition in the urban context**. To create a **common vision and to position the concept of PEDs**, the PED Programme has developed a [framework definition](#) that needs specification and operationalisation in local contexts.

The AGORA workshop on PEDs aims at **developing in an interactive setting a joint understanding of PEDs through various stakeholder groups by**

- **Sharing experiences on different approaches to the PED concept**
- **Elaborating the operationalization of the PED Framework according to regional/local perspectives**
- **Identifying and elaborating roles and perspectives of different stakeholder groups regarding the PED concept**



Preparation

As a preparation, all registered participants will be asked to provide their **expertise, perspective and key messages on the ambition of developing Positive Energy Districts and Neighbourhoods** or the development of climate neutral/energy efficient urban environments in a short abstract/position paper (400 – 500 words). The contributions will be compiled in a **booklet of abstracts** and distributed among participants, which will serve as a basis for the workshop. A final version of the booklet will be published on the JPI Urban Europe Website.
